

Guardianship Requirements

Coming to the UK or Ireland to study is a big step for any international student. Our guardianship supports and encourages students to achieve all that they can during this time.

HSI guardianship is included in all our academic programmes in the United Kingdom and Ireland

It can also be taken as a stand-alone programme.

Our guardianships are available for students at private boarding, private day, private prep and public (state) schools.

Who can apply for HSI Guardianship?

- Students aged 8 to 18 attending either a homestay or boarding school programme
- Students who have been offered a place in a British or Irish school
- Students who are studying in the United Kingdom or Ireland without their parents

Standard and Basic Guardianship

HSI offers two levels of guardianship:

Standard

Our standard guardianship service provides the highest level of supervision and progress monitoring available. This thorough service gives students the support they need to reach their full potential whilst away from home.

Basic

Basic guardianship is suitable for students who require a more limited level of care than we offer in our standard guardianship.

Basic guardianship is only available to students aged 16 or over, and who are on a boarding programme.

Guardianship: A Student's Journey

Before you leave home

- HSI Office / Organises a suitable host family (homestay programmes only) and puts you in contact with them by email
- HSI Office / Organises a transfer service to meet you at the airport on arrival







 Student Advisor / Meets you in your first two weeks for an orientation visit

Regularly throughout

- Student Advisor / Meets you regularly to monitor your progress and well-being
- Student Advisor / Writes progress and well-being reports and sends them to the HSI office
- Student Advisor / Attends parent-teacher meetings
- HSI Office / Ensures all progress reports and important school documents are sent to the natural parents
- HSI Office / Arranges and manages mid-term and exeat and other holiday host families as required ●
- HSI Office / Arranges additional transfers as required ●
- HSI Office / Is available by phone 24/7 for emergencies ●
- Student Advisor & HSI Office / Work together to swiftly resolve any problems during your programme



At the end of your programme

- HSI Office / Arranges departure transfers to airport ●
- HSI Office / Ensure all validation documents are obtained and delivered to agents/natural parents

What makes HSI Guardianship so special?

1. Our Office Teams

We have local offices in Brighton and Dublin. Each office is staffed with professionals in the fields of programme operations, student welfare and guardianships.

Some of our team have been with us over 25 years, offering a wealth of experience and reliability for our students and their families.

We aim to make guardianship simple and stress-free whilst ensuring that all the safeguards are in place to ensure students are happy and well during their study abroad programme.

2. Our Student Advisor network

Our Student Advisors are the face of our service. Students develop a relationship with their Advisor throughout the duration of their programme.

In Ireland, our Student Advisors are professional student welfare officers and are based in our Dublin office.

In the United Kingdom, Student Advisors live locally to our partner schools and are members of the local community who are experienced in working with young people.

3. Our Host Families

HSI host families are some of the best available. They are more than just a place to sleep, they are a home-away-from-home for our students.

On both standard and basic guardianship most students will need homestay accommodation.

Rather than travelling home during each holiday or school closure, it is often more convenient to spend the time with a local host family.

HSI Host Family standards

All our host families meet rigorous standards before they can host a HSI student. Families must be able to provide a private bedroom, a quiet space to study, 2 meals per day (3 at weekends) plus snacks, and a warm, welcoming environment in which our students can live.

All HSI host families treat their host student as a member of the family, and many remain friends-for-life.

Safeguarding

Our students' safety is our primary concern, and therefore we implement a range of methods to ensure that the host families we choose are suitable and well prepared for the role of hosting.

These include:

- visiting each host family prior to placement
- completing a comprehensive House & Home Inspection report
- completing police background checks
- obtaining personal references
- ensuring the home has a valid gas safety certificate
- providing the family with the HSI Child Protection Policy
- providing the family with guidelines and advice for hosting

Most students will require additional accommodation with a host family at some point during their stay. During mid-term breaks and boarding house closures it is easier for students to stay locally.

We will coordinate the placement of students into nearby inspected and vetted host families for students who require it.

Assistance with transfers

Before, during and at the end of each student's study programme, staff from our UK or Ireland offices are in contact with parents or partner agencies to confirm flight details and airport transfer arrangements if applicable.

We can offer young-flyer drop-off and collection services when necessary through our own staff or partner taxi firms. When we use taxis, our partner taxi firms employ only vetted and verified drivers.



Problem Solving and Emergency Care

Our dedicated office teams are available for students, parents and partners during office hours. We deal with enquiries efficiently so that you have accurate information when you need it.

24/7 emergency telephone service

Sometimes unexpected situations can happen which need immediate attention. Every student will have access to our 24/7 emergency telephone service. In the event of an emergency any student under our care will be able to speak to a member of HSI staff and get the issue resolved as quickly as possible.

Emergency visits

Standard Guardianship

Students may need to ask advice, raise concerns, or require a visit from their Student Advisor at short notice. Students can use their preferred way to keep in touch with their Student Advisor so that they can be confident in the level of care they will receive.

Incident reports

We provide an incident report for parents and partner agencies. Our incident reports are in addition to any other that may be produced by the school or other party associated with the incident.



Academic, social and welfare monitoring

Orientation Visit

Our local Student Advisor will meet students shortly after arrival. The purpose of this visit is to give the student all the information they need while under our guardianship and to welcome them to their new environment.

Minimum of 2 visits per term

Standard Guardianship

Students on our standard guardianship programme will benefit from meeting with their Student Advisor one-to-one on a regular basis. In Ireland students will meet their Student Advisor at least once a month. In both the UK and Ireland, these meetings are private and give students an opportunity to talk about their academic progress, social environment and living arrangements; and to express any concerns or worries they might have.

Progress & Well-Being Reporting

Standard Guardianship

We are in regular contact with all our partner agencies, parents and schools, ensuring that the flow of information between students, schools and parents is as efficient and accurate as possible.

Following each meeting with a student, our Student Advisors write a detailed report on the progress of that student and any issues or concerns which need to be addressed. These reports are received by our UK or Ireland HSI head office and passed on to parents and partner agencies to keep them informed about their son/daughter's progress and well-being.

Attendance at Parent-Teacher evening

Standard Guardianship

Our trained Student Advisors will attend parent-teacher evenings. This is an opportunity for teachers to discuss how the student is performing at school. All feedback is reported to the local HSI head office and shared with parents and partner agencies.
